## **RESOLUTION NO. 682-2022**

DECLARING MUNICIPAL ORDINANCE NO. 03-2022 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING THE POSITIONS OF LOCAL LEGISLATIVE ASSISTANT III, SALARY GRADE 10 AND ADMINISTRATIVE AIDE IV, SALARY GRADE 4 UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 03-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;
