APPROVING RESOLUTION NO. 2022-233 OF THE SANGGUNANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3, CALENDAR YEAR 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2022-233 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 3 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2022 dated June 3, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental AIP, which has a total investment requirement of ₱6,503,000.00, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of LGU; and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 1 for CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-01 dated June 22, 2022.




