RESOLUTION NO. 688-2022

APPROVING RESOLUTION NO. 600, S-2019-22 OF THE SANGGUNANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3 OF THE CITY OF URDANETA FOR CY 2022 IN THE AMOUNT OF THIRTY-THREE MILLION FOUR HUNDRED THIRTY-FIVE THOUSAND SEVENTY-SIX PESOS AND SEVENTY-FIVE CENTAVOS ONLY (P33,435,076.75)."

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its SP Resolution No. 600, S-2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Urdaneta City, Pangasinan had identified items in their Supplemental Annual Investment Program No. 3 CY 2022. This was endorsed to the Sangguniang Panlungsod for approval on January 6, 2022 by the City Development Council through Resolution No. 3-2022;
2. The Supplemental Annual Investment Program No. 3 of the city covers the implementation of priority programs and projects of the Local Government Unit of Urdaneta; and

3. Funding support for the implementation of the same in the amount of Php33,435,076.75 is embodied in their proposed Supplemental Budget No. 3 CY 2022, which was enacted by their Sangguniang Panlungsod through Ordinance No.71, Series of 2019-22 on March 7, 2022.




