RESOLUTION NO. 690-2022

DECLARING ORDINANCE NO. 03, S-2022 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "AN ORDINANCE STRENGTHENING THE SCHOLARSHIP PROGRAM OF THE MUNICIPALITY OF ASINGAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 03, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xi) of R. A. No. 7160 and Republic Act No. 109311, otherwise known as "Universal Access to Quality Tertiary Education Act" and Republic Act No. 10648 entitled "An Act Providing Scholarship Grants to Top Graduates of All Public High Schools in State Universities and Colleges and Appropriating Funds Therefor";

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Carolyn D. Sison, duly seconded, it was—




