PROVINCIAL RESOLUTION NO. 691-2022

**CREATING AN AD HOC COMMITTEE FOR BOUNDARY
DISPUTE OF THE 11TH SANGGUNIANG PANLALAWIGAN**

WHEREAS, Section 118 of RA No. 7160 mandates the Sangguniang Panlalawigan to resolve boundary disputes between municipalities within the Province;

WHEREAS, it also provides that boundary disputes between municipalities of adjoining provinces shall be resolved by and between the concerned Sangguniang Panlalawigan;

WHEREAS, the Sangguniang Panlalawigan is in receipt of a request for the settlement of a boundary dispute between the Municipality of Sison, Province of Pangasinan, and the Municipality of Tuba, Province of Benguet;

WHEREAS, it is the concern of the 11th Sangguniang Panlalawigan to take action on this boundary dispute through an Ad Hoc Committee;

WHEREAS, the Ad Hoc Committee aims to tackle this pending boundary dispute before the Sangguniang Panlalawigan, and if there are other disputes that would arise then its resolutions could be addressed right away;

WHEREAS, in view of the absence of a standing committee in the 11th Sangguniang Panlalawigan directly involved in boundary disputes, there is a need to create a Special Committee tasked to conduct hearing/ocular inspection, invite key personalities concerned, undertake studies and evaluation and submit its findings or recommendation on the matter;

WHEREFORE, in view of the foregoing, on motion of SP Member Nicholi Jan Louie Q. Sison, duly seconded, it was –

RESOLVED, FURTHER, that the said Ad Hoc Committee shall be composed of the following:


1. Vice Governor Mark Ronald DG. Lambino – *Chairman*
