**PROVINCIAL RESOLUTION NO. 695-2022**

**CONGRATULATING THE PHILIPPINE DRUG  
ENFORCEMENT AGENCY (PDEA) AND THE  
PANGASINAN POLICE PROVINCIAL OFFICE (PPPO) IN  
THEIR RECENT DRUG OFFENSIVE OPERATION IN  
POZORRUBIO, PANGASINAN**

**WHEREAS**, the Philippine Drug Enforcement Agency (PDEA) and the Pangasinan Police Provincial Office (PPPO) have seized ₱2.5 billion worth of methamphetamine hydrochloride, more popularly known as *shabu* in a buy-bust operation in Pozorrubio, Pangasinan;

**WHEREAS**, the PDEA and PPPO, the lead agencies in-charge in the crusade and battle against the tentacles of dangerous drugs, have arrested four suspects involved in the illegal drug trade;

**WHEREAS**, the significant accomplishments of the PDEA and PPPO highlighted by one of the biggest buy-bust operations in Pangasinan happened in Barangay Banding, Pozorrubio, Pangasinan last August 12, 2022;

**WHEREAS**, the PDEA and PPPO, under the leadership of Pangasinan Provincial Director Rechie Q. Camacho and PCol. Richmond L. Tadina, respectively, have proven its dedication and determination to focus on an intensified implementation of drug clearing program of the present and past administrations of the national government;

**WHEREAS**, the Province of Pangasinan fully supports the accomplishments of the PDEA and PPPO since one of its growing concerns is the proliferation of illegal drugs in the Province which is considered a menace of the society;


