PROVINCIAL RESOLUTION NO. 696-2022

COMMENDING AND CONGRATULATING CONGRESSMAN MARK O. COJUANGCO, REPRESENTATIVE OF THE 2ND DISTRICT (PANGASINAN), FOR HIS ELECTION AS CHAIRMAN OF THE SPECIAL COMMITTEE ON NUCLEAR ENERGY OF THE HOUSE OF REPRESENTATIVES

WHEREAS, the House of Representatives has created the Special Committee on Nuclear Energy that will be tasked to tackle policies and program relating to the production, utilization and conservation of nuclear energy, as well as the development of nuclear power infrastructures and the interaction of other energy sources with nuclear energy as a reliable, cost-competitive, and environment-friendly energy source;

WHEREAS, the House of Representatives has elected 2nd District Representative Mark O.
