## **RESOLUTION NO. 697-2022**

DECLARING ORDINANCE NO. 2022-03 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING A DISCIPLINE ZONE IN THE CITY OF ALAMINOS, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2022-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 16 and 458 (a) (1) (ii) and (iii) and (4) (ii) of RA 7160, DILG Memorandum Circular No. 2019-181 or the "Disiplina Muna National Advocacy Campaign" and RA 6975 or "An Act Establishing the Philippine National Police Under a Reorganized Department of the Interior and Local Government, and for Other Purposes";

**WHEREAS**, however, the Sangguniang Panlungsod shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 2, 2022;

WHEREAS, subject ordinance shall take effect after the Sanguniang Panlungsod has complied with the requirement of publication pursuant to Section 511 (a) of RA 7160;
