RESOLUTION NO. 698-2022

APPROVING RESOLUTION NO. 060, S-2022 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 002-2022 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF THIRTY-FOUR MILLION SEVEN HUNDRED FIFTY THOUSAND (P34,750,000.00) PESOS"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 060, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council-Executive Committee of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 2 for CY 2022 of the LGU. This was endorsed by the Council, through MDC Resolution No. 2-2022, Series of 2022 dated June 14, 2022 to the Sangguniang Bayan for approval;
2. Said Supplemental AIP, which has a total investment requirement of P34,750,000.00, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlays of some departments of the LGU, and implementation of development projects of the municipality; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2 for FY 2022, which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 002-2022 dated June 22, 2022.




