PROVINCIAL RESOLUTION NO. 704-2022

APPROVING THE ACCREDITATION OF MBK LC., INCORPORATED (MY BROTHER'S KEEPERS LIFE COACHES, INCORPORATED) AND REV UP CHARITY RIDERS FOR 1 PH INCORPORATED FOR PURPOSES OF MEMBERSHIP AND PARTICIPATION IN THE PROVINCIAL SPECIAL LOCAL BODIES PROVIDED UNDER THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083 on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the MBK LC, Incorporated (My Borthor's Keeper Life Coaches Inc.) and Rev Up Charity Riders for 1PH Incorporated through its Presidents, Mr. Rolando E. Santiago and Mr. Renan B. Lopez, respectively, have signified their intention to be an accredited CSO in the Province of Pangasinan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the MBK LC, Incorporated (My Borthor's Keeper Life Coaches Inc.) and Rev Up Charity Riders for 1PH Incorporated have satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG Memorandum Circular 2022-083;




