### PROVINCIAL RESOLUTION NO. 708-2022

#### **APPROVING THE RENEWAL FOR ACCREDITATION OF THE PHILIPPINE DENTAL ASSOCIATION – PANGASINAN CHAPTER FOR PURPOSES OF MEMBERSHIP AND PARTICIPATION IN THE PROVINCIAL SPECIAL LOCAL BODIES PROVIDED UNDER THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083 on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;




