PROVINCIAL RESOLUTION NO. 713-2022

INVITING THE REGIONAL DIRECTOR OR THE DULY AUTHORIZED REPRESETATIVE/S OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT TO APPEAR BEFORE THE SANGGUNIANG PANLALAWIGAN OF PANGASINAN DURING ITS QUESTION HOUR TO APPRISE THE BODY ON THE IMPLEMENTATION OF THE EDUCATIONAL ASSISTANCE PROGRAM IN THE PROVINCE OF PANGASINAN

WHEREAS, the Department of Social Welfare and Development (DSWD) has initiated a cash assistance program to help indigent students for the School Year (SY) 2022-2023;

WHEREAS, through the program, the DSWD has started giving cash assistance to children coming from poor families to buy for their needs such as school supplies, uniform, shoes and for payment of school fees; and others;

WHEREAS, the Sangguniang Panlalawigan would like to be informed of the policies and procedures to be undertaken by the DSWD to ensure the smooth implementation of the program in the Province of Pangasinan;

WHEREAS, thousands of Pangasinenses are expected to benefit from the said cash assistance program and it is the earnest desire of the Sangguniang Panlalawigan to assist the people by giving them the right information on the standard operating procedures to be adopted by the DSWD's cash distribution transactions in order to attain a fast, continuous and uninterrupted delivery of services;
