PROVINCIAL RESOLUTION NO. 713-2022

INVITING THE REGIONAL DIRECTOR OR THE DULY AUTHORIZED REPRESENTATIVE/S OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT TO APPEAR BEFORE THE SANGGUNANG PANLALAWIGAN OF PANGASINAN DURING ITS QUESTION HOUR TO APPRISE THE BODY ON THE IMPLEMENTATION OF THE EDUCATIONAL ASSISTANCE PROGRAM IN THE PROVINCE OF PANGASINAN



WHEREFORE, on motion of SP Member Noel C. Bince, duly seconded, it was


