**WHEREAS**, the Commission confirms or rejects certain political appointments made by the President of the Philippines;

**WHEREAS**, the CA does not curtail the President's appointing authority but serves as a check against its abuse, as it assures that the President has exercised the power to appoint wisely by appointing only those who are fit and qualified;

**WHEREAS**, the CA is composed of the Senate President as the ex-officio Chairman, twelve (12) Senators and twelve (12) members of the House of Representatives;

**WHEREAS**, the House of Representatives has appointed as its Head of Contingent to the CA, Honorable Ramon N. Guico, Jr., the Congressman of the Fifth (5th) District of Pangasinan;

**WHEREAS**, the appointment of Congressman Guico as the Head of the Contingent of the House of Representatives is a testament of his able leadership and outstanding reputation for impartiality;


