RESOLUTION NO. 716-2022

DECLARING ORDINANCE NO. 2022-01 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING DENGUE PREVENTION AND CONTROL PROGRAM FOR THE MUNICIPALITY OF BOLINAO, PANGASINAN TO STRENGTHEN THE FIGHT AGAINST DENGUE AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Ordinance No. 2022-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to DILG Memorandum Circular No. 2005-74, and Memorandum Circular No. 2010-92 and Sections 16, 17 (a) (2) (vi) and 447 (a) (5) (xii) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer stated in her opinion dated August 15, 2022;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;


