RESOLUTION NO. 717-2022

APPROVING RESOLUTION NO. 2022-44 OF THE SANGGUNANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 CY 2022, AS EMBODIED IN THE MDC RESOLUTION NUMBER 1, SERIES OF 2022 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SB Resolution No. 2022-44 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Section 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bolinao, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 1 for CY 2022. This was endorsed to the Sangguniang Bayan on June 3, 2022, through MDC Resolution No. 1, Series of 2022;
2. Said SIP No. 1 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses, Capital Outlay of some municipal offices, and implementation of priority programs/projects of the local government unit; and

3. Funding support for the proposed SIP with a total investment requirement of Php14,924,882.00, is embodied in the municipality's Supplemental Budget No. 1 for CY 2022, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-01 on June 30, 2022.




