**WHEREAS**, Regional Special Personnel Order No. 2208-037 of the Department of Finance, dated August 25, 2022, provides for the official designation of Ms. Cristy C. Ubando, Supervising Administrative Officer of the Provincial Treasury Office, as Acting Assistant Provincial Treasurer of the Provincial Government of Pangasinan in view of the retirement of Mr. Romeo E. Oca;




