PROVINCIAL RESOLUTION NO. 725-2022

APPROVING THE ACCREDITATION OF VARIOUS CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE PROVINCE FOR PURPOSES OF MEMBERSHIP AND PARTICIPATION IN THE PROVINCIAL SPECIAL LOCAL BODIES PROVIDED UNDER THE LOCAL GOVERNMENT CODE OF 1991

NOW, THEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was


