DECLARING MUNICIPAL ORDINANCE NO. 2022-02 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “AN ORDINANCE TO CREATE FOUR PLANTILLA POSITIONS OF NURSE III SG 17, PHARMACISTS I SG 11, WATERWORKS SUPERINTENDENT I SG 18 AND SENIOR ADMINISTRATIVE ASSISTANT II (COMPUTER OPERATOR IV) SG 14, OF THE MUNICIPALITY OF BOLINAO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
