RESOLUTION NO. 734-2022

DECLARING MUNICIPAL ORDINANCE NO. 2022-03 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE BOLINAO TOURISM OFFICE AND THE POSITION OF SENIOR TOURISM OPERATIONS OFFICER AS ITS HEAD WITH SALARY GRADE 18 OF THE MUNICIPALITY OF BOLINAO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2022-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2022-03 of the Sangguniang Bayan of Bolinao, Pangasinan, entitled “An Ordinance creating the Bolinao Tourism Office and the position of Senior Tourism Operations Officer as its Head with Salary Grade 18 of the Municipality of Bolinao, Pangasinan” as within the conferred powers of the Sanggunian to enact;




