APPROVING RESOLUTION NO. 2022-47 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "ADOPTING MDRRMC RESOLUTION NO. 2, SERIES OF 2022 ENTITLED "RESOLUTION AMENDING THE PROJECT NAME OF ONE (1) PRIORITY PROJECT UNDER THE 20% DEVELOPMENT FUND FROM REHABILITATION OF SWM OFFICE AT BOLINAO SANITARY LANDFILL TO CONSTRUCTION OF SWM OFFICE AT BOLINAO SANITARY LANDFILL"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SB Resolution No. 2022-47 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- Subject resolution amends the project name of one project, which was include/part of previously approved Annual Investment Program CY 2022, from "Rehabilitation of SWM office at Bolinao Sanitary Landfill" to "Construction of SWM Office at Bolinao Sanitary Landfill";
- 2. Said amendment emanated from the Local Development Council and endorsed the same to the Sangguniang Bayan for approval on June 3, 2022 thru MDC Res. No. 2, Series of 2022.
