APPROVING RESOLUTION NO. 2022-102 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2, C.Y. 2022 OF SUAL, PANGASINAN AMOUNTING TO TWENTY-SIX MILLION SEVEN HUNDRED SEVENTY-NINE THOUSAND ONE HUNDRED FIFTY-ONE & 49/100 PESOS (P26,779,151.49)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its SB Resolution No. 2022-102 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Section 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 2 for CY 2022. This was endorsed to the Sangguniang Bayan on June 30, 2022, through MDC Resolution No. 3, Series of 2022;
2. The Said SIP No. 2 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses, Capital Outlay of some municipal offices, and implementation of priority programs/projects of the local government unit; and

3. Funding support for the implementation of the same in the amount Php26,779,151.49 is embodied in their proposed Supplemental Budget No. 02 s. 2022, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03 on August 3, 2022.


