## **RESOLUTION NO. 738-2022**

DECLARING ORDINANCE NO. 074-2022 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 2 (10) (A) AND SECTION 3 (B) OF ORDINANCE NO. 072-2022 ENTITLED "AN ORDINANCE CREATING THE OFFICE OF THE HUMAN **RESOURCE MANAGEMENT (HRMO) AND OFFICE OF THE** MUNICIPAL MANPOWER DEVELOPMENT AND VARIOUS PLANTILLA POSITIONS IN EXECUTIVE AND LEGISLATIVE DEPARTMENTS OF THE MUNICIPAL GOVERNMENT AND **ABOLISHING THE PLANTILLA POSITIONS OF SUPERVISING** ADMINISTRATIVE OFFICER (HRMO IV) IN THE OFFICE OF AND AGRICULTURAL THE **MUNICIPAL** MAYOR TECHNOLOGIST IN THE OFFICE OF THE MUNICIPAL AGRICULTURIST" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 074-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Sections 443 (c) (2), 447 (a) (1) (viii), 76, 77, 78, 79, 80 of RA 7160;

WHEREAS, however the Sangguniang Bayan shall consider the points raised by the Local Finance Committee stated in its opinion dated August 5, 2022;
