## **RESOLUTION NO. 740-2022**

APPROVING RESOLUTION NO. 2022-20 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2022-03 OF THE SUPPLEMENTAL BUDGET NO. 2022-03 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of San Manuel, Pangasinan submitted its SB Resolution No. 2022-20 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Local Development Council of San Manuel, Pangasinan has formulated the municipality's Annual Investment Program No. 2022-03 thru MDC Resolution No.03, Series of 2022 dated June 16, 2022 to the Sangguniang Bayan for approval. This is pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
- The Supplemental Investment Program No. 2022-03 has an investment requirement amounting to Php567,651.00 which covers fund augmentation for the personal services and maintenance and other operating expenses, of some offices of the LGU San Manuel; and

3. To support the implementation of the programs embodied in the Supplemental Investment Program No. 2022-03, the Sangguniang Bayan enacted Supplemental Budget No. 2022-03 through Appropriation Ordinance No. 03, Series of 2022 dated June 22, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Manuel, Pangasinan;
