RESOLUTION NO. 741-2022

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2022 OF SAN MANUEL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P567,651.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Supplemental Budget No. 03 for Calendar Year 2022 involving total appropriations of P567,651.00, which was enacted on June 22, 2022 through Appropriation Ordinance No. 03, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding source for the subject supplemental budget was determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and
- That the grant of Year-End Bonus and Cash Gift for FY 2022 to municipal officials and employees shall be subject to the provisions of Budget Circular No. 2016-4 of the Department of Budget and Management dated April 28, 2016.
