APPROVING RESOLUTION NO. 22-28 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "RESOLUTION APPROVING MDC RESOLUTION NO. 2022-01 ENTITLED, ENDORSING TO THE SANGGUNIANG BAYAN FOR APPROVAL OF THE AMENDMENT IN THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 (SAIP NO. 3) FY 2022 OF SANTA MARIA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its SB Resolution No. 22-28 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Local Development Council of Sta. Maria, Pangasinan amended their previously approved SIP#3 FY 2021 particularly the title of one project from "Construction of Two (2) Storey Commercial Building" to "Construction of Two (2) Storey Commercial Building at vacant space owned by the Municipal Government along Rizal Street corner National Highway". This was endorsed to the Sangguniang Bayan on June 24, 2022 thru MDC Resolution No. 2022-01.
- 2. The said project is proposed to be funded from the loan proceeds from the Land Bank of the Philippines.
