PROVINCIAL RESOLUTION NO. 744-2022

APPROVING THE ALLOCATION OF AN ENVIRONMENTAL GUARANTEE FUND TO BE USED FOR THE APPLICATION FOR WESTERN PANGASINAN DISTRICT HOSPITAL, EASTERN PANGASINAN DISTRICT HOSPITAL, LINGAYEN DISTRICT HOSPITAL, MANGATAREM DISTRICT HOSPITAL, URDANETA DISTRICT HOSPITAL, BAYAMBANG DISTRICT HOSPITAL, AND THE PANGASINAN PROVINCIAL HOSPITAL TO OPERATE A SHREDDER

WHEREAS, the Pangasinan Provincial Hospital and the six (6) District Hospitals, namely: Western Pangasinan District Hospital, Eastern Pangasinan District Hospital, Lingayen District Hospital, Mangatarem District Hospital, Urdaneta District Hospital, and Bayambang District Hospital cater to patients coming from the different municipalities and cities in the Province of Pangasinan;

WHEREAS, the Provincial Government of Pangasinan, through the said hospitals, is further improving its medical health facilities by providing a shredder intended for its medical waste treatment and sterilization;

WHEREAS, one of the requirements for the application of permit to operate a shredder is the passage of a measure for the allocation of Environmental Guarantee Fund (EGF);

WHEREAS, an EGF shall be readily accessible and disbursable for the immediate clean-up or rehabilitation of areas affected by damages in the environment and the resulting deterioration of environmental quality as a direct consequence of the operation of a shredder;
