PROVINCIAL RESOLUTION NO. 745-2022

REQUESTING THE COMMITTEE ON INFRASTRUCTURE, PUBLIC SERVICES AND UTILITIES TO CONDUCT COMMITTEE HEARING, IN AID OF LEGISLATION, TO DETERMINE THE PRESENT STATUS OF THE DAANG KALIKASAN ROAD

WHEREAS, the Daang Kalikasan Road Project is a 54-kilometer roadline that connects Region I on the part of the Province of Pangasinan in Barangay Muelang, Mangatarem to Region III on the part of the Province of Zambales in Barangay Guisguis, Sta. Cruz;

WHEREAS, the Daang Kalikasan Road has become a favorite tourist attraction in the Province of Pangasinan as it has been frequently visited by the townspeople of nearby localities;

WHEREAS, a tree planting activity was held recently at the Daang Kalikasan in Barangay Muelang, Mangatarem, Pangasinan which was participated in by various government agencies, civil society organizations and other volunteer groups;

WHEREAS, it is the intention of the Sangguniang Panlalawigan to conduct an inquiry primarily to know from the concerned authorities the status of the Daang Kalikasan Road and determine what agency or local government unit would be responsible or accountable for the maintenance of the road, including public safety, peace and order, cleanliness and protection of the area;

WHEREAS, the Sangguniang Panlalawigan has fully supported the construction of the Daang Kalikasan Road as it would boost the development of transportation and infrastructure in Northern Luzon to further enhance trade and tourism, however, it is also the desire of the Body to be informed of the status of the same;

WHEREAS, the Sangguniang Panlalawigan as the highest legislative body of the Province is empowered to conduct an inquiry/committee hearing on certain matters that are of public interest and in aid of legislation;

WHEREAS, the Committee on Infrastructure, Public Services and Utilities is the proper Body to conduct the said committee hearing as the matter on construction and maintenance of roads is within its specific area of legislation to address;

WHEREAS, the inquiry should be set the soonest possible time and be participated in by the Regional Office and 2nd Pangasinan Engineering District Office of the Department of Public Works and Highways, the Municipal Government of Mangatarem, Pangasinan and other concerned authorities that can ventilate on the matter;

WHEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to request, as it is hereby requested, the Committee on Infrastructure, Public Services and Utilities to conduct committee hearing, in aid of legislation, to determine the present status of the Daang Kalikasan Road;

RESOLVED, FURTHER that a copy of this resolution be furnished to the Honorable Chairman of the Committee on Infrastructure, Public Services and Utilities, SP Member Salvador S. Perez, Jr., for his information and appropriate action.
