PROVINCIAL RESOLUTION NO. 747-2022

INVITING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB), LAND TRANSPORTATION OFFICE ((LTO) AND THE ASSOCIATIONS OF BUS AND JEEPNEY OPERATORS IN PANGASINAN TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN TO APPRISE THE BODY ON THE IMPENDING FARE INCREASES FOR PUBLIC UTILITY VEHICLES AND ITS EFFECT TO THE PUBLIC

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) is an agency of the Department of Transportation (DOTr) which is mandated to regulate land-based public transportation, and to safeguard the welfare and interests of the commuting public;

WHEREAS, the LTFRB has recently approved a fare increase for traditional and modern jeepneys, buses, and other public utility vehicles which will take effect by October of this year;

WHEREAS, while the Sangguniang Panlalawigan recognizes the plight of Pangasinenses every time an increase on price of commodities occur, including the cost of public transport, they would also like to be informed of the impact of fare increases to both the commuters and drivers;

WHEREAS, on the other hand, one of the continuing commitments of the Land Transportation Office is the promotion of safety and comfort in land travels;

WHEREAS, with the impending fare increases for public utility vehicles, the Sangguniang Panlalawigan would also like to be informed on how the LTO can effectively implement transportation rules and regulations to protect the commuters and drivers for fast and efficient public service;

WHEREAS, Section 20 of the Internal Rules of Procedure of the 11th Sangguniang Panlalawigan of Pangasinan provides that a Question Hour is the period of time allotted for members of the Sanggunian to ask questions from invited resource persons coming from both the government and private sectors, usually heads of offices, technical men and prominent individuals, primarily intended to seek information from the latter on certain matters that are of public interest and in aid of legislation;
