FAVORABLE ENDORSEMENT FOR THE CONVERSION
OF THE LINGAYEN-BINMALEY BAYWALK ROADLINE
INTO A NATIONAL ROAD**

WHEREAS, one of the priority programs of the present administration, under the leadership of Honorable Governor Ramon V. Guico III, is for the development of the baywalk located along the Municipalities of Lingayen and Binmaley in the Province of Pangasinan;

WHEREAS, the development of the baywalk along the areas will enhance and upgrade the tourism potential of the famous Lingayen Gulf, and also the status of the aforementioned local government units;

WHEREAS, the Lingayen-Binmaley Baywalk Roadline with an approximate length of 13 kilometers are vital arteries connecting central and western portions of Pangasinan;
