PROVINCIAL RESOLUTION NO. 750-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION WITH THE UNITED NATIONS CHILDREN’S FUND (UNICEF) FOR THE ACCEPTANCE AND TRANSFER OF OWNERSHIP OF COLD CHAIN EQUIPMENT AND DEVICES

WHEREAS, the United Nations Children’s Fund or UNICEF is an important partner of the Philippines in the implementation of programs covering education, health and nutrition, disaster risk reduction and emergencies, HIV and AIDS prevention, child protection and rescue, communication, local policy and institutional development;

WHEREAS, the UNICEF has begun providing assistance to the Philippine Government in November 1948 and in pursuance to the Memorandum of Agreement signed between the two parties, the former has committed to provide various equipment assistance to the government by way of increasing its vaccine storage facility;

WHEREAS, the Province of Pangasinan will be the recipient of cold chain equipment and devices from UNICEF through a grant from COVAX for use in the Vaccine Storage under the National Immunization Program and COVID 19 vaccines;

WHEREAS, the acceptance and transfer of ownership by the Provincial Government of Pangasinan of cold chain equipment and devices from the UNICEF in the form of donation shall consist of the following:

WHEREAS, the cold chain equipment and devices can be used by the Province for storage purposes in order to cater and respond immediately to the health necessities of the people under the National Immunization Program and COVID 19 vaccines;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to sign a Deed of Donation and accept the cold chain equipment and devices from the UNICEF to further augment the need for the implementation of health programs and services to the people of Pangasinan;


WHEREAS, for the above purpose, a Deed of Donation shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the UNICEF, represented by Ms. Oyunsaikhan Dendevnorov;

NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


