PROVINCIAL RESOLUTION NO. 764-2022

EXPRESSING THE FULL AND UNCONDITIONAL SUPPORT AND ASSISTANCE OF THE SANGGUNIANG PANLALAWIGAN BY WAY OF TAKING POSITIVE ACTIONS TO ADDRESS THE LONG-STANDING BOUNDARY DISPUTE BETWEEN THE MUNICIPALITIES OF SAN NICOLAS, PANGASINAN AND STA. FE, NUEVA VIZCAYA

WHEREAS, a boundary dispute between the municipalities of San Nicolas, Pangasinan and Sta. Fe, Nueva Vizcaya involving Barangay Malico has long been existing up to the present;

WHEREAS, the boundary dispute has dragged on for sometime and has remained unresolved up to this time;

WHEREAS, the Sangguniang Panlalawigan received an information that the Sangguniang Panlalawigan of Nueva Vizcaya has approved a resolution urging the Province of Pangasinan and the Municipality of San Nicolas, Pangasinan to only build their infrastructure projects outside Barangay Malico and respect the Memorandum of Agreement between and among the National Mapping and Resource Information Authority (NAMRIA), and the Provinces of Pangasinan and Nueva Vizcaya;

WHEREAS, in pursuance of its mandate under Section 118 (c) of RA 7160, the Sangguniang Panlalawigan fully supports the resolution of this boundary dispute by taking positive actions to address the same;

WHEREAS, there is need to continue with the interrupted proceedings and hold a joint meeting between the Sangguniang Panlalawigan of Pangasinan and Nueva Vizcaya and other concerned officials to resolve the boundary dispute;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Noel C. Bince, duly seconded, it was –


