PROVINCIAL RESOLUTION NO. 767-2022

REQUESTING THE OFFICE OF THE CIVIL DEFENSE TO FACILITATE THE DONATION OF VARIOUS EQUIPMENT AND OTHER FACILITIES TO FURTHER AUGMENT THE NEEDED SUPPORT FOR DISASTER RISK REDUCTION AND MANAGEMENT PROGRAM OF THE PROVINCE

WHEREAS, the Office of the Civil Defense is mandated to administer a comprehensive civil defense and disaster risk reduction management program towards a safer and resilient community;

WHEREAS, the Provincial Government of Pangasinan, through the Provincial Disaster Risk Reduction and Management Office, is further improving its services to continually systematize and strategize the Province's programs to manage the occurrences and consequences of disasters;

WHEREAS, at present, the following various disaster preparedness equipment and other facilities are needed to further augment the logistical requirement of the Province of Pangasinan, to wit:

Equipment:

1. Manlift Truck
2. Truck-Mounted Generators (built-in)
3. Water Tanker Truck

Facilities:

1. Evacuation Centers for 5 municipalities along Agno River (Bayambang, Mangatarem, Bautista, Labrador, Aguilar)
2. DRRM Training Center/Building in Burgos, Pangasinan
3. Rescuer's Barracks in Eastern Operations Center, Tayug

NOW, THEREFORE, on motion of SP Member Philip Theodore E. Cruz, duly seconded, it was –


