APPROVING RESOLUTION OF NO. 22-063 THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS. **"APPROVING** PANGASINAN, ENTITLED THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FOR CALENDAR YEAR 2022 OF THE CITY OF SAN CARLOS, **PROVINCE OF PANGASINAN"**

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its SP Resolution No. 22-063 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution with the following findings:

- The City Development Council Executive Committee of San Carlos City, Pangasinan prepared the Supplemental Investment Program (SIP) No. 3, CY 2022. This was endorsed by the Council, through CDC Resolution No. 03-22 (Series of 2022) dated June 3, 2022, to the Sangguniang Panlunsod for approval;
- 2. Said Supplemental Investment Program (SIP), which has a total investment requirement of ₱3,576,527.98, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOEs) and Capital Outlay (CO), and implementation of priority projects of the LGU; and

> Funding for the SIP will be sourced from the Savings/Surplus of the LGU as embodied in the LGU's Supplemental Budget No. 03-22, FY 2022, which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 22-05, dated June 13, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
