APPROVING RESOLUTION NO. 419, SERIES OF 2022 OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THRU RESOLUTION NO. 001, SERIES OF 2022 WITH ITS CORRESPONDING PROGRAMS, PROJECTS AND ACTIVITIES (PPAs) INCURRING A TOTAL OF SEVENTEEN MILLION SEVEN HUNDRED FORTY NINE THOUSAND SIX HUNDRED SIXTY NINE PESOS ONLY (PHP17,749,669.00)"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its SB Resolution No. 419, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Bayambang, Pangasinan prepared the Supplemental Annual Investment Program No. 1 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 001, Series of 2022 dated August 3, 2022, to the Sangguniang Bayan for approval.

- 2. The Supplemental AIP, covers the implementation of the project: Construction of Core Local Access Road at Barangay Pantol, Bayambang, with a total project cost of ₱17,749,669.00 from the Tobacco Excise Tax Share of LGU Bayambang. (An initial amount of ₱3,300,000.00 is reflected in the LGU's AIP, CY 2022 and the remaining ₱14,449,669.00 is contained in the LGU's proposed SAIP No. 1, CY 2022.
- 3. The identified project conforms with Local Budget Memorandum Nos. 83 and 84 of the Department of Budget and Management, and RA 8240 as amended by RA No. 10351.
- 4. Funding support for the Supplemental AIP is embodied in their Supplemental Budget No. 01, CY 2022 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2022 dated August 30, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 419, S-2022 of the Sangguniang Bayan of Bayambang, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 1 duly indorsed by the Municipal Development Council (MDC) thru Resolution No. 001, Series of 2022 with its Corresponding Programs, Projects and Activities (PPAs) incurring a total of Seventeen Million Seven Hundred Forty Nine Thousand Six Hundred Sixty Nine Pesos Only (Php17,749,669.00)";
