**RESOLUTION NO. 778-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF BAYAMBANG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P17,749,669.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Supplemental Budget No. 01 for Calendar Year 2022 involving total appropriations of P17,749,669.00, which was enacted on August 30, 2022 through Appropriation Ordinance No. 01, S-2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the utilization of appropriations from FY 2018 and FY 2019 shares of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum Nos. 83 and 84 dated November 22, 2021;

2. That all programs, projects and activities shall be in accordance with the approved CY 2022 Supplemental Investment Program of the Municipality; and
3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


