RESOLUTION NO. 780-2022

DECLARING ORDINANCE NO. 2022-06 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED "AN ORDINANCE IMPOSING RENTAL FEE AND OTHER FEES AND CHARGES FOR THE USE OF SPACE/STALL AND OTHER FACILITIES TO THE NEWLY CONSTRUCTED EASTERN PART OF PUBLIC MARKET OF SAN MANUEL, PANGASINAN, AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Municipal Ordinance No. 2022-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 447 (a) (3) (i) of R. A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of posting and publication pursuant to Sections 59 (c) and 188 of R.A. 7160;


