RESOLUTION NO. 781-2022

DECLARING MUNICIPAL ORDINANCE NO. 4-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ALL KINDS OF ANIMALS TO STRAY IN PUBLIC PLACES IN THE MUNICIPALITY OF URBIZTONDO AND APPROVING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 4-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (4) (viii) of R. A. No. 7160, R.A. No. 9482, otherwise known as the "Anti-Rabies Act of 2007" and R.A. No. 8485, otherwise known as "The Animal Welfare Act of 1998";

WHEREAS, subject ordinance shall take effect after the Sanguniang Bayan has complied with the requirement of publication pursuant to Section 511 (a) of R.A. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
