DECLARING MUNICIPAL ORDINANCE NO. 6-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR GOODWILL AND MONTHLY RENTAL FEES FOR THE ONE HUNDRED **TWENTY THREE (123) STEEL MATTED STALLS AND TWENTY THREE (23) EATERIES AND REFRESHMENT COMMERCIAL** STALLS LOCATED AT BUILDINGS 1, 2, 3 AND ARAMBULO BUILDING LOCATED AT THE URBIZTONDO PUBLIC MARKET, URBIZTONDO, PANGASINAN AND PROVIDING **GUIDELINES FOR OCCUPANCY AND OPERATION THEREOF"** CONFERRED POWERS WITHIN THE OF THE AS SANGGUNIAN TO ENACT
