**RESOLUTION NO. 790-2022**

**DECLARING ORDINANCE NO. 2022-09 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING LOCAL SOCIAL PENSION PROGRAM TO INDIGENT SENIOR CITIZENS OF THE CITY OF ALAMINOS, PANGASINAN WHO ARE NOT INCLUDED IN THE ACTUAL LIST OF BENEFICIARIES OF THE SOCIAL PENSION PROGRAM FROM THE NATIONAL GOVERNMENT, PROVIDING GUIDELINES AND FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2022-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Republic Act No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010", Sections 17 (b) (2) (iv) and 458 (a) (5) (xvii) of RA 7160, and Article XV, Section 4 of the Philippine Constitution;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—




