### RESOLUTION NO. 795-2022

**DECLARING ORDINANCE NO. 177, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING ONE (1) POSITION OF ADMINISTRATIVE AIDE I UNDER THE OFFICE OF THE MUNICIPAL MAYOR AND ONE (1) POSITION OF ADMINISTRATIVE AIDE III (UTILITY WORKER II) UNDER THE OFFICE OF THE MUNICIPAL ACCOUNTANT OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**




