APPROVINGING RESOLUTION NO. 2022-62 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 01, CALENDAR YEAR 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2022-62 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer of the Province have conducted initial review and study on said SP Resolution with the following findings:

- 1. The Municipal Development Council-Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Program (SAIP) No. 1, for CY 2022. This was endorsed by the Council, through MDC Resolution No. 1, Sereies of 2022 dated March 9, 2022, to the Sangguniang Bayan for approval;
- 2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱3,689,481.50, covers production and infrastructure support for tobacco farmers of the municipality; and

> The identified projects, which will be sourced from the Tobacco Excise Tax Share of the LGU, conform with Local Budget Memorandum Nos.
> 83 and 84 of the Department of Budget and Management (DBM).
