RESOLUTION NO. 802-2022

DECLARING ORDINANCE NO. 5, S-2022 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "AN ORDINANCE PRESCRIBING GUIDELINES FOR THE OPERATION OF PUBLIC SWIMMING POOLS, AND OTHER SIMILAR STRUCTURES AND ACCOMMODATIONS WITH BATHING AND/OR RECREATIONAL FACILITIES TO PROVIDE DULY CERTIFIED LIFEGUARDS AND LIFEGUARDING EQUIPMENT NECESSARY FOR THEIR OPERATION, PROVIDING PENALTY FOR VIOLATION THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Municipal Ordinance No. 5, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to the provisions of Section 16 under the General Welfare Clause, Sections 17 (2) (vi) and 447 (1) (iii) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 and 511(a) of R.A. 7160;




