APPROVING RESOLUTION NO. 21-A, S-2022 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPAL BUDGET NO. 2, S-2022 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 21-A, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer of the Province have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of San Quintin, Pangasinan thru its Executive Committee has formulated and endorsed the municipality's Supplemental Investment Program thru MDC Executive Committee Resolution No. 2, S. 2022 dated August 2, 2022, to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;
2. The Supplemental Investment Program with an investment requirement amounting to Php2,500,000.00 covers fund augmentation for the Maintenance and Other Operating Expenses (Gas, Oil and Lubricants and Electricity Expenses) of LGU San Quintin; and

3. The Sangguniang Bayan enacted Supplemental Budget through Appropriation Ordinance No. 08, S-2022 dated August 22, 2022 to support the implementation of the Supplemental Investment Program No. 2 of the municipality.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Quintin, Pangasinan;


