PROVINCIAL RESOLUTION NO. 811-2022

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE I FOR THE IMPLEMENTATION OF THE GOVERNMENT INTERNSHIP PROGRAM (GIP) IN THE PROVINCE OF PANGASINAN

WHEREAS, the national government has been determined in defining its role to help the local government units in the application of policies, programs and projects to generate more jobs and reduce poverty in the countryside;

WHEREAS, the Government Internship Program (GIP) is a program of the Department of Labor and Employment (DOLE) that aims to provide employment to poor/indigent workers;

WHEREAS, the DOLE-GIP would give an internship opportunity for Pangasinense-applicants to obtain work experience in government agencies and offices at the local and national levels;

WHEREAS, the DOLE had chosen the Province of Pangasinan as its GIP Partner Agency through its 14 government hospitals, namely:

NOW THEREFORE, on motion of SP Members Shiela Marie F. Baniqued and Jerry Agerico B. Rosario, duly seconded, it was -


