RESOLUTION NO. 821-2022

DECLARING ORDINANCE NO. 128, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTING AND IMPLEMENTING THE REGISTRATION OF OWNERSHIP OF AGRICULTURAL AND FISHERIES MACHINERY AND EQUIPMENT IN ACCORDANCE WITH THE JOINT MEMORANDUM CIRCULAR NO. 2018-02 BY THE DEPARTMENT OF AGRICULTURE (DA) AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) RELATIVE TO THE NATIONAL GUIDELINES FOR THE REGISTRATION OWNERSHIP OF AGRICULTURAL AND FISHERIES MACHINERY AND EQUIPMENT WITHIN THE TERRITORIAL JURISDICTION OF SAN NICOLAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 128, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section (132) (447) (a) (3) (i) of RA 7160, Republic Act No. 10601, otherwise known as "Agricultural and Fisheries Mechanization Law" and Joint Memorandum Circular No. 2018-02;


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 128, S-2022 of the Sangguniang Bayan of San Nicolas, Pangasinan, entitled “An Ordinance instituting and implementing the registration of ownership of agricultural and fisheries machinery and equipment in accordance with the Joint Memorandum Circular No. 2018-02 by the Department of Agriculture (DA) and the Department of Interior And Local Government (DILG) relative to the national guidelines for the registration ownership of agricultural and fisheries machinery and equipment within the territorial jurisdiction of San Nicolas, Pangasinan” as within the conferred powers of the Sanggunian Bayan to enact;
