DECLARING ORDINANCE 2022-01 OF NO. THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE HEREIN NEW PLANTILLA POSITIONS IN THE MUNICIPAL GOVERNMENT OF CALASIAO AS FOLLOWS: UNDER THE MAYOR'S OFFICE/PERSONAL STAFF (EXECUTIVE ASST. IV - SG 22), MAYOR'S **OFFICE/INFORMATION** UNDER THE TECHNOLOGY SECTION (INFORMATION TECHNOLOGY OFFICER I - SG 19), UNDER THE ENGINEERING OFFICE (ZONING OFFICER III – SG 18), UNDER THE OFFICE OF THE MUNICIPAL VICE MAYOR/PERSONAL STAFF 4) AND (ADMINISTRATIVE AIDE IV (DRIVER II-SG (ADMINISTRATIVE AIDE I SG 1) IN THE MUNICIPALITY OF CALASIAO, PANGASINAN" AS WITHIN THE CONFERRED **POWERS OF THE SANGGUNIAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 2022-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to the provisions Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Local Finance Committee stated in her opinion dated September 27, 2022;
