PROVINCIAL RESOLUTION NO. 832-2022

ENJOINING ALL INSTITUTIONS, AGENCIES AND INSTRUMENTALITIES TO CONDUCT PROPER CONSULTATION WITH THE PROVINCIAL GOVERNMENT OF PANGASINAN BEFORE ANY INFRASTRUCTURE DEVELOPMENT ARE MADE WITHIN OR ADJACENT TO PROVINCIAL GOVERNMENT PROPERTIES AROUND THE PROVINCE

WHEREAS, the Sangguniang Panlalawigan as the legislative body the Province is empowered to enact measures that would redound to the benefit of the people of Pangasinan in pursuance to the provision of the general welfare clause of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, every now and then, the Provincial Government is in receipt of different requests from various entities seeking approval or endorsement of their respective projects, undertakings or activities;

WHEREAS, hence, several national government agencies are already established in the Provincial Capitol Compound either through a deed of donation, usufruct, or lease, not to mention also the approval of similar requests involving other properties of the Province outside of the Capitol Compound;

WHEREAS, the Sangguniang Panlalawigan expresses concern over the increasing infrastructure activities or development within or adjacent to the Provincial Capitol Compound or to any provincial government properties around the Province which may result to the degradation of the environment and likewise, affect the aesthetic values of the properties or inconsistent with zonal requirements of such properties;

WHEREAS, the Sangguniang Panlalawigan desires to have a clearer picture of the physical status of the properties of the Province and come up with a comprehensive direction of its land using activities, environmental management, and development of other physical resources;

WHEREAS, it is about time that the buildings, social settings and environmental surroundings within or adjacent to the Provincial Capitol Compound and other provincial government properties of the Province be aligned with existing physical framework plan and other zoning regulations in order to have a more systematic, aesthetic and orderly disposition of the areas;

WHEREAS, it is the stand of the Sangguniang Panlalawigan that in the implementation of infrastructure development within or adjacent to provincial government properties around the province, it is important that social, environmental and economic benefits can be gained from it, in pursuance however, to the approved Executive and Legislative Agenda (ELA) of the Provincial Government of Pangasinan;

WHEREAS, there is a need therefore for the Sangguniang Panlalawigan to enjoin all institutions, agencies and instrumentalities to conduct proper consultation with the Provincial Government of Pangasinan before any development projects and programs are made within or adjacent to provincial government properties around the province;

NOW THEREFORE, on motion of SP Member Philip Theodore E. Cruz, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to enjoin, as they are hereby enjoined, all institutions, agencies and instrumentalities to conduct proper consultation with the Provincial Government of Pangasinan before any infrastructure development are made within or adjacent to provincial government properties around the province;

RESOLVED FINALLY, to furnish copies of this resolution to all institutions, agencies and instrumentalities of the Province of Pangasinan, for their information and guidance.
