**PROVINCIAL RESOLUTION NO. 834-2022**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE OFFICE OF REPRESENTATIVE CHRISTOPHER P. DE VENECIA FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE TO INDIGENT PATIENTS (MAIP) PROGRAM IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Medical Assistance to Indigent Patients (MAIP) Program is a Department of Health program intended to provide financial support to indigent and poor patients seeking medical examination, consultation, treatment and rehabilitation and those confined in government hospitals;

**WHEREAS**, the Department of Health Center for Health Development-I (DOH CHD I) has chosen the Province of Pangasinan to facilitate the implementation of the Medical Assistance to Indigent Patients (MAIP) Program;

**WHEREAS**, in pursuance of DOH Administrative Order No. 2020-0060 dated December 23, 2020, the Department of Health is authorized to enter into a Memorandum of Agreement with local government units to ensure effective realization of the said medical assistance program;

**WHEREAS**, the Office of Representative Christopher P. de Venecia, through the Department of Health, has allocated/downloaded a total budget of P500,000.00 at Mapandan Community Hospital for the implementation of MAIP intended for medical assistance to the constituents within the 4<sup>th</sup> District of Pangasinan;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Office of Representative Christopher P. De Venecia, represented by Atty. Gerald M. Tabadero, District Chief of Staff;


