**PROVINCIAL RESOLUTION NO. 835-2022**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE MEMORANDA OF AGREEMENT (MOA) WITH THE BUGALLON RHU I AND BIRTHING FACILITY, AND BUGALLON RHU II BIRTHING HOME FACILITY FOR THE USE OF THE AMBULANCE OF THE LINGAYEN DISTRICT HOSPITAL FOR TRANSPORT AND REFERRAL OF EMERGENCY CASES**

**WHEREAS**, the provincial government is an active partner of the cities and municipalities in the promotion of its worthwhile plans and programs particularly in the protection of the health and well-being of the people;

**WHEREAS**, the Lingayen District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 2<sup>nd</sup> District of Pangasinan;

**WHEREAS**, the Bugallon RHU I and Birthing Facility, and Bugallon RHU II Birthing Home Facility are among the catchment areas of the Lingayen District Hospital;

**WHEREAS**, the Bugallon RHU I and Birthing Facility, and Bugallon RHU II Birthing Home Facility intend to seek the ambulance service of the Lingayen District Hospital;

**WHEREAS**, the Lingayen District Hospital agreed to provide medical and ambulance service needs of the Bugallon RHU I and Birthing Facility, and Bugallon RHU II Birthing Home Facility in terms of x-rays and clinical laboratory examination, confinement of patients (if needed), OB-Gyne referrals and pediatric cases;

**WHEREAS**, DOH Administrative Order No. 2018-0001 on the Revised Rules and Regulations Governing the Licensure of Land Ambulances and Ambulance Service Providers provides that birthing facilities at a minimum are required to enter into a Memorandum of Agreement with ambulance service providers (whether government or privately owned) but may also opt to own an ambulance;


**WHEREAS**, for the above purpose, the Memoranda of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III and the Bugallon RHU I and Birthing Facility, and Bugallon RHU II Birthing Home Facility, represented by Mayor Priscilla I. Espino;

**NOW THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign the Memoranda of Agreement (MOA) with the Bugallon RHU I and Birthing Facility, and Bugallon RHU II Birthing Home Facility for the use of the ambulance of the Lingayen District Hospital for transport and referral of emergency cases;
